Vehicle Use Policies

1. All non-street legal motorized vehicles (NSLMV), must be registered with Whitehall Camp & Conference Center before operating on Whitehall property.
2. All NSLMVs must be registered to a leaseholder in good standing, or a guest renting lodging from Whitehall Camp.
3. License plates for registered NSLMVS will be issued and must be placed on the front and back of the registered NSLMV.
4. Speed limit on the Campground is 10 miles per hour. Since most NSLMVs are not equipped with speedometers, the speed of a fast pace walk is appropriate.
5. No person may operate any motor vehicle on Camp property if he/she does not possess a current driver's license. This provision applies to all NSLMVs.
6. All NSLMVs must be maintained mechanically, and operated in a safe manner, included but not limited to, observing all speed limits and signage, avoiding reckless driving, and observing maximum seating capacity.
7. NSLMVs are for transportation purposes, and are not to be used for activities on camp property that are reasonably understood to be recreational "off road riding".
8. Any NSMLV being operated after dark on camp property must have front and rear lights in proper working order.
9. All NSLMVs should be operated with courtesy to all campers. Care and consideration should be given for the safety of those walking, jogging, bicycling, and those in the use of mobility assistance devices.
10. All motor vehicle operators are to abide by any and all directions that are given by, Whitehall Staff, Whitehall Board, Whitehall Security, and the Camp Meeting Planning Team, during Camp meeting.
11. Failure to comply with Vehicle Use Policies or heed the directions given by authorized individuals may result in the loss of privileges, as it pertains to the possession, and use of any NSLMV on Whitehall property.
